**AUTHORIZE AGREEMENT WITH LIL' ATHLETES  
RES. #43-16**

Upon motion by Deputy Mayor Emanuel Zuckerman, seconded by Trustee Clara Pomerantz, it was

RESOLVED, to authorize the Mayor to sign the agreement with Lil' Athletes for their services for KIP programming on the Theater Lawn on the Sunday dates and times detailed in the agreement. The cost charged by Lil' Athletes will be \$170/child for a 7 week session.
