#### MAYOR'S REPORT

Trustee Pomerantz explained the Neighbors-for-Neighbors program. The Village of Port Washington has also expressed interest in copying East Hills' program. The newly formed committee is openly looking for volunteers to assist other neighbors throughout the Village. Trustee Siegel reported on upcoming Kids in the Park events. Trustee Pomerantz announced the next Friends for Friends meeting will be held on April 22<sup>nd</sup> at the Roslyn High School from 5 pm – 6 pm. Deputy Mayor Zuckerman reported on an upcoming National Grid project involving the installation of a 24" main gas pipe on the North Service Road of the Expressway. The construction is scheduled to commence during the first week of May and continue for approximately 6 months. The work will take place between 8 pm and 5 am with only local traffic being allowed through. The construction will run from Old Westbury Road and continue to Willis Avenue.

The Town of North Hempstead will be hosting an upcoming anti-Semitic forum.
