**BILL T1-2016, PROPOSED LOCAL LAW REPEALING AND REPLACING CHAPTER 137, ARTICLE II, § 137-22 A (17) OF THE VILLAGE CODE REGARDING RULES AND REGULATIONS FOR THE PARK AT EAST HILLS
