MAYOR'S REPORT

Mayor Koblenz wished everyone a happy and safe holiday and happy New Year. He went on to state that the building on the hill should be demolished before the Park opens on Memorial Day. The Mayor said his vision down the road is an indoor sports facility to be built in stages. The first step is retaining the services of an architect to create designs. If feasible, the fitness center would also possibly be moved into the new building allowing for a larger space and more amenities. The current building on the hill is loaded with toxic waste and is a big mess such as having collapsing ceilings and roof damage. It saved the Village \$250,000 to be kept up at the time of the original Park construction. Deputy Mayor Zuckerman stated that the Village-wide camera project is coming to fruition. A \$250,000 grant will be funding a major portion of the project. Trustee Pomerantz reminded everyone about the new technology tutoring program on Sundays at the Senior Center.

GOOD AND WELFARE

The Board invited Adam Haber to make a slide-show presentation on cost-saving ideas for municipalities. The Mayor said that the Village is always looking for ways to cut costs.
