MAYOR'S REPORT

Mayor Koblenz reported that the weather has been hot, the pool works and everyone is happy. The Village purchased 650 new pool chairs and the old inventory is waiting to be sold. It was estimated that there were over 5000 people in attendance for the 4th of July celebration which included DJ music, bands, a fireworks show, and a kids parade. A committee will be selected in the fall to look into the feasibility of building of an indoor sports facility at the location where one of the old National Guard buildings was removed. Possible future plans are for the building of an indoor sports facility. Deputy Mayor Zuckerman said plans are moving forward to install a camera system on utility poles throughout the Village. Trustee Siegel reported that the Kids in the Park Committee will be hosting "Sundaes on Mondays", the School of Rock will

be sponsoring and performing at the "Endless Summer" event and the women's softball league currently has 4 teams that play on Wednesdays at 6:45; new players are welcomed. Trustee Pomerantz reported on details of Green Day and Wellness Day events which are scheduled for August 24th and August 25th, respectively. Exhibitors interested in participating are asked to contact Trustee Pomerantz.
