LONGEVITY PAYMENTS – NON-UNION FULL-TIME EMPLOYEES RES. #-19

RESOLVED, to authorize Longevity Pay increases for non-union full-time employees as follows:

Conclusion of 5 years of service \$600 Conclusion of 10 years of service \$850 Conclusion of 15 years of service \$1,100 Conclusion of 20 years of service \$1,500 Conclusion of 25 years of service \$1,750

Longevity pay will be paid at the next pay period following the employee's anniversary of completion of the year identified. Payments shall be subject to appropriate withholdings. Each longevity payment is a separate and distinct lump sum payment, which is paid once per accrual period (i.e., at the 5th year, 10th year, etc.) and shall not be incorporated into an employee's hourly rate and/or weekly salary for future compensation. An employee who prior to ratification may have had longevity pay incorporated into his/her payroll shall not suffer a reduction in his/her hourly rate as a result of this provision going forward – although all future longevity pay awards shall be lump sum payments in accordance with this provision.

GOOD AND WELFARE

Resident Mr. Kruger inquired about the unfinished house on Deerpath and what's happening with it. He also reported pooling of water at the location of Andover and the Service Road which has occurred since PSEG repaved half of the road during their gas line installation project. Dr. Trager thanked Trustee Pomerantz and the Village for the invite to participate in Wellness Day and made some suggestions for inclusion in next year's event, such as blood pressure monitoring, diabetes awareness, driver safety course, and vaping education. He said he was very impressed with the pool and the park facilities.
