#### OPPOSITION TO THE ELIMINATION OF THE FEDERAL DEDUCTION FOR STATE AND LOCAL TAXES RES. #161-17

Upon motion by Deputy Mayor Zuckerman, seconded by Trustee Pomerantz, the following resolution was unanimously adopted.

WHEREAS Congress is giving serious consideration to eliminating the federal income tax deduction for state and local taxes;

WHEREAS this deduction, which has been in place for more than 100 years, is heavily utilized by residents of our community and our State;

WHEREAS New York residents already pay more into the federal treasury than the federal government returns to New York;

WHEREAS the state and local tax deduction is a fundamental principle of federalism and without it our residents would be faced with double taxation as they would be forced to pay federal income taxes on the taxes they pay to state and local governments;

WHEREAS this federal cost shift onto local governments would place extreme pressure on municipal budgets, including diminished revenue for essential local government investments, including public safety and public infrastructure; and

WHEREAS increased federal taxation and reduced municipal services will harm our local housing market, decrease home values and erode our local tax base,

NOW THEREFORE BE IT RESOLVED THAT the Inc. Village of East Hills expresses its strong opposition to any tax reform proposal that would eliminate the State and Local

Tax (SALT) Deduction and urges Representative Thomas Suozzi and Senators Charles Schumer and Kirsten Gillibrand to join us in publicly opposing any such proposal.

## DEPARTMENTAL REPORTS

The Departmental Reports were accepted as submitted. The grand total of Village Justice Court funds collected for the month of July 2017 was \$28,351.

# **MAYOR'S REPORT**

Mayor Koblenz reported that the pool is closed and drained. Everyone had a great summer. There were only two incidents causing "dump" closures. Overall, the pool season had decent weather. The Mayor stated that if anyone wants to become certified by the Red Cross as a lifeguard or knows of anyone who already is, that the Village would be interested in interviewing them for hire as the Village is unable to keep the pool open longer due to losing our lifeguard staffing because of school obligations.

The regular meeting was adjourned for a scheduled hearing on ZTR Committee proposals.

Mayor Koblenz explained that the ZTR committee proposals, most of which only apply to new construction or if a home is substantially renovated. The purpose of this second hearing on the proposed changes are to review comments that were received and to take additional comments. Mayor Koblenz further explained that the door remains open on comments and/or anything that is creative and that will benefit and improve the community. Village consultants, Kathy Eiseman and Mike Russo were present to explain the comments that were received. Mike Russo said they made recommendations for changes to Chapter 117, which is the lighting code, Chapter 223, which is the building construction code, and Chapter 271, which is the zoning code. Mr. Russo further stated that following the hearing on July 20<sup>th</sup>, he and Kathy Eiseman met with the Village Building Department, as well as the Village Attorney, and they prepared

provisions to the code, amendments which he will be reviewing this evening. Among other things, Mr. Russo clarified how the yards are calculated as it relates to impervious, a basement which extends beyond the footprint of the house being calculated in FAR, clarification to stationary outdoor fireplaces, etc. being added to site structures/accessory structures, clarifying in the zoning section of the code the existence of Chapter 127 having to do with noise, visual dishes, and modification to fees in Section 271-138. Resident Peter Goldfeder, architect Michael Wallin, Mr. Nann, residents Jeff Krugman, Joel Sheinbaum, Bejan Golian, Edward Rubin, Lauren Hoffma and May Ganzo all spoke and posed questions. Sean Hedvat, builder Bob Preston, resident Gil Vilkas, resident Oran Kraft and real estate broker Shadi Arzanipour and residents Ramin Emouna and Brian Kolan also addressed the Board and Mr. Russo with their questions and concerned opinions. Mr. Russo reiterated that the proposed new regulations apply solely to new homes and substantial improvements and explained further details of the proposed regulations. Spencer Kanis, Chairman of the Architectural Review Board also spoke explaining the community's input behind the proposed changes and what the ARB has experienced over the last ten years from the applications that have come before that Board. He stated that the proposed changes are in reaction to the needs of the community based upon years of written testimony and written statements on the record of what the ARB has faced and clarifying a code so it is more easily understood. Following further discussion and there being no more business, the meeting was adjourned at 10:10 p.m.
