Mayor Koblenz explained that the fire company notified the Deputy Mayor that they want to buy two fire trucks in excess of \$2 million. The Deputy Mayor asked for some basic information, but did not receive it. Until it is received, the Village is not inclined to sign the contract. The Village's share under the contract is \$940,555; \$475,683 is for Roslyn Hook and Ladder and \$464,872 is for Roslyn Highlands. The floor was opened for comment. Following discussion, a motion was made by Trustee Pomerantz, seconded by Trustee Meyerson to close the public hearing and authorize the Mayor to sign the Roslyn Fire Contract subject to counsel's review of legal approval.

DEPARTMENTAL REPORTS

The Departmental Reports were accepted as presented. The grand total of Village Justice Court funds collected for the month of January 2020 was \$41,212.

MAYOR'S REPORT

Mayor Koblenz reported that we have had very little snow which is a good thing for us and the budget.

GOOD AND WELFARE

Resident Adam Haber, who has a background as Head of Economic Development at the Town of Hempstead and as an energies trader, made a presentation and Q & A regarding a Community Choice Aggregation Program which involves gas buys in bulk ahead of time from an alternate provider from National Grid and creates a potential cost-savings to ratepayers. The Village's combined residential accounts are utilized to negotiate a better and more stable supply price. Mr. Haber stated that the Town of Hempstead is currently taking its first steps to initiate a CCA program. The Board and public posed questions. A concern was raised regarding automatic enrollment of residential accounts. Mr. Haber explained that a ratepayer who doesn't wish to participate can then opt out at any time and switch back to National Grid. The Board

thanked Mr. Haber for his presentation and said they would take the matter into consideration.

EXECUTIVE SESSION RES. #33-20

A motion was made by Deputy Mayor Zuckerman, seconded by Trustee Pomerantz, to convene to Executive Session pursuant to Open Meetings Law §105(1)(d), to discuss an employment matter. The motion was unanimously approved.
