#### DISCUSSION PROPOSED BILL T2-22, LEAF BLOWER RESTRICTIONS

The Board discussed the proposed bill on leaf blower restrictions. Dave Squillante was asked to contact professionals in the field to come back with information and recommendations for the board to consider regarding the use of gas leaf blowers and alternatives.

#### **DISCUSSION PUBLIC NUISANCE LAW**

The Board discussed a possible Public Nuisance Law banning public urination, defecation. Village Attorney Burton said he will research the current Village Code and report back to the Board.

#### **DISCUSSION SPLASH PAD**

Trustee Siegel discussed the latest proposal of PlaySafe Recreation and Aquatic Designs dated February 2, 2022. The Board asked for more spray features and a five year warranty. Trustee Siegel and Village Attorney Burton reported that the purchase is eligible for piggybacking off of an existing contract. Mr. Burton said he would supply the same to the Village Clerk. Trustee Siegel said that she and Dave Squillante will be in touch with Playsafe and report back with an updated proposal.

#### **MAYOR'S REPORT**

Mayor Koblenz reported on the crazy weather we are having. On Saturday, it was 60 degrees and on Sunday we have 3.5" of snow. The weekend prior we have 12" of snow. For the record, the Mayor said that the DPW department did an outstanding job and the Village received compliments from residents who were happy. This coming weekend, heavy rains and flooding is predicted.

#### **GOOD AND WELFARE**

The Board discussed fireworks for the 4<sup>th</sup> of July. The date of July 4<sup>th</sup> has been reserved as reported by Dave Squillante. Trustee Siegel reported on the progress of the Lakeville/Nob Hill entrance walls moving along. Mayor Koblenz reported on the previous night's ARB meeting at which they reviewed the applications of the new houses proposed at Mimosa Drive, the old pool club. He also spoke about the restoration of the gatehouse which the Village acquired the deed to. It is estimated that the cost will run about \$400,000. The Village has received \$100,000 from the builder and assistance from the landmark society is being looked into.
