Trustee Siegel reported on the installation of a bus shelter on north side of Harbor Hill Road @ Short Street, as well as quotes she has received for the installation of a new pool interactive and splash pad. Mayor Koblenz further reported on conversations he has had with two residents, one regarding a pickle ball court and one regarding the dog park, and their progress with pursuing private sponsorships to help fund their desired projects. The Board also discussed the implementation of a pilot program for a change in the sanitation/recycling schedule for one route as part of the program.
