### PUBLIC HEARING ON BILL T3-22 – LOCAL LAW 2-22 RES. #-22

Upon motion by Trustee Pomerantz, seconded by Mayor Koblenz, and unanimously carried, the public hearing on proposed Bill T3 of 2022, a local law amending Chapter 271, Section 14 of the Code of the Village of East Hills as it relates to fences, was opened.

Village Attorney William C. Burton explained that the proposed bill codifies the permission and authorization to the Board of Zoning Appeals to allow any type of pool fence that the BZA determines in its discretion is appropriate around the perimeter of the home. In addition, the bill also grandfathers in the fences for pools which have been deemed to be inconsistent and authorizes the residents to get a certificate of compliance or other such appropriate mechanism or vehicle.

The floor was opened for discussion. Following comments, a motion to close was made by Trustee Pomerantz, seconded by Trustee Meyerson to close the hearing; motion was unanimously carried.

To help stem this situation, the ARB is recommending that the Board of Trustees increase the Green Fund contribution from \$300 to \$500.
