DRAFT MINUTES OF THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF EAST HILLS DECEMBER 16, 2020

At a virtual meeting of the Board of Trustees of the Incorporated Village of East Hills held on December 16, 2020, the Mayor called the meeting to order at 7:30 pm. Mayor Michael R. Koblenz noted a quorum. The following Board of Trustees members were present:

Mayor Koblenz introduced Lee Snead, as one of the Village's outside counsel representing the Planning Board and Zoning Board. Attorney Snead explained two proposed bills before the Board, one instituting a moratorium on Demolition or Modification of Structures that are in excess of 89 years of age or greater within the Village of East Hills, and one regarding a local law prohibiting the demolition or alteration of a structure 89 years or older without permit, and authorizing the institution of a civil action for violation thereof, and establishing criminal penalties therefor. A moratorium would allow time for the Village to identify possible historic structures within the Village and then craft appropriate legislation in the event the Board decides it needs to amend its current Code. It would suspend the Building Inspector's ability to issue a permit where property or structure exists and portion of structure was built prior to the incorporation of the Village, but contains a provision for an applicant to come before the Village Board at a public hearing to request an exception during the moratorium period.
