# DRAFT MINUTES OF THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF EAST HILLS APRIL 3, 2023

At a meeting of the Board of Trustees of the Incorporated Village of East Hills held on April 3, 2023 Mayor Koblenz called the meeting to order at 5:30 pm. Mayor Koblenz noted a quorum. The following Board of Trustees members were present:

#### OATH OF OFFICE - SWEARING IN OF ELECTED OFFICIALS

Town of North Hempstead Councilman Peter Zuckerman swore into office Mayor Michael R. Koblenz, Justice Howard Jaslow, Trustee Brian Meyerson and Trustee Stacey Siegel.

Mayor Barbara Donno of the Village of Plandome Manor was also present representing Senator Jack Martin who sent his apologies for his delayed attendance.

All present congratulated the newly elected Village of East Hills officials, as well as Mayor Donno, on winning their re-election bids.

#### GRAFFITI REMOVAL MACKAY ESTATE GATE LODGE – SURFACE RESTO RES. #-23

The Roslyn Landmark Society, as part of the Phase 1 development plan for the Mackay Estate Gate Lodge project, contacted over 20 companies concerning their graffiti removal services. Three companies provided wage cost estimates based on prevailing wages. Following the calling of references and based on the vendor's expertise in removing graffiti from historic buildings, the Roslyn Grist Mill Committee strongly recommends Surface Resto to perform the work based on expertise in removing graffiti from historic buildings, cost estimates and timing.
