MAYOR'S REPORT

Mayor Koblenz spoke about safety matters. The Village is on high alert and has assigned extra security patrols in the wake of the October 7, 2023 terrorist attack in Israel. Overtime has been authorized and the patrol vehicle roof lights will be on 24/7. Additionally, Nassau County Police Department has also assigned additional patrols in the Village. Trustee Pomerantz provided information regarding collections that are being coordinated to send needed supplies to Israel.

GOOD AND WELFARE

Mr. Richard Brummel emailed a communication to the Board earlier in the day suggesting the village adopt practices, software and systems to make records and videos maximally available permanently and to also ask that the Board revisit the issue of environmental protection, specifically in regard to trees, greenery and wildlife. Westwood Circle Civic Association President and Village resident Jeff Krugman inquired about the Village's recycling program. He stated that he has received concerns from civic association members that proper sorting of recyclables by the sanitation crew is not be followed.
