The Mayor acknowledge receipt of an extensive letter from Richard Brummel and further acknowledged that it has been distributed to the Board and made part of the record of this meeting.

The Mayor discussed the Village of Roslyn Harbor's plans to permit a cell tower and noted that there is to be a demonstration at the Roslyn Harbor Village Hall and he urged residents to go on the record in protest and to attend their next Board of Trustees meeting.

The Mayor discussed his zoom meeting with Michael Scheid, the Long Island Regional Director for Senator Gillebrand regarding airplane traffic.

GOOD AND WELFARE

Robin Brattner spoke at length about the efforts of the airplane Noise Committee and requested funding from the Village for litigation. She described her efforts to speak with various officials at the FAA, Air Traffic Control and other government officials, and described data that has been collected and reviewed by the Committee. The Mayor and Mr. Burton explained that they have just allocated funds to be used for this purpose provided that other villages also engage in this effort, and they discussed past difficulties with getting other municipalities to participate. Mr. Burton also explained why a study needs to be completed by aviation experts. Mayor Koblenz asked Mrs. Brattner to provide tentative dates to meet with Senator Gillibrand's aide Michael Scheid.
