PUBLIC HEARING FOR BILL T02-2023 A PROPOSED LOCAL LAW LOCAL REGARDING SEPTIC SYSTEMS FOR NEW AND SUBSTANTIALLY IMPROVED HOMES RES. #-23

Mayor Koblenz opened the public hearing for Bill T02-2023, a proposed local law requiring nitrogen-reducing septic systems for all new and substantially improved homes.

Thomas Murphy, Building Inspector described the new sanitary system requirements.

Mayor Koblenz asked for questions or comments from the public. No one spoke in favor of or against the proposed Bill.

Upon Motion by Deputy Mayor Zuckerman, seconded by Trustee Pomerantz, the Board unanimously voted to declare themselves the lead agency for the purposes of SEQRA, declare this an unlisted action, close the public hearing and adopt Bill T02-2023 as Local law 2-2023.

DISCUSSION – AIRPLANE NOISE

Mayor Koblenz introduced Michael Scheid, Long Island Regional Director for Senator Gillibrand. Mr. Scheid explained that he was here on behalf of the Senator to collect information on the airplane noise problem so that the Senator's office can begin to work towards a solution with the FAA. Mayor Koblenz also introduced Town of North Hempstead Councilman Peter Zuckerman, and Elliot Conway, Mayor of Upper Brookville and President of the Nassau County village Officials Association (NCVOA). He then opened the meeting up for public comment.

Tom Piccoli, 3 Rockhill Road, explained the data that has been collected on the airplanes overhead. He noted that 76% of all JFK arrivals come in on single runway path. He explained the criteria that contribute to runway selection (wind direction, wind speed, volume). He also noted that planes should be flying at over 2000 feet but many planes fly under this altitude over East Hills.

Robin Brattner, 118 Crescent Lane, said that they have proposed reasonable solutions to the FAA with no success. Her concern is that the FAA is choosing volume of flights and the money that brings in over the quality of life of the residents of Long Island. Specifically she explained that Runway 22 has more efficient taxiways to turn around passengers faster, and as a result air traffic control uses this runway approach even when the conditions are suitable for using other approaches such as the ocean approach.

Mayor Conway explained that this is also an important issue for the residents of Upper Brookville, and he acknowledged that this is one of the NCVOA's top priorities.

Councilman Peter Zuckerman noted that this affects all of Nassau County, not only East Hills, and added his personal observation that that the planes fly very low over East Hills.

Anne Marie Sirone, a resident of Manhasset, expressed anger and frustration over the constant plane noise, and also voiced environmental health concerns.

Jason Bratner, 118 Crescent Lane, expressed concern also over potential health impacts in addition to the noise pollution.

Keri Bergman, 215 Elm Drive, comments on the emotional toll of the constant noise.

Mr. Scheid thanked the residents and representatives for the comments and feedback presented.

DISCUSSION - SUFFOLK COUNTY CATERERS

The Board discussed the possible use of Suffolk County Caterers LLC for the Park Grille for concession. The length of the contract, menu items, quality of food, pricing, and responsiveness were discussed.

Upon motion by Trustee Pomerantz, seconded by Trustee Siegel, the Board unanimously voted to authorize the Mayor to negotiate terms of a contract with Suffolk County Caterers.
