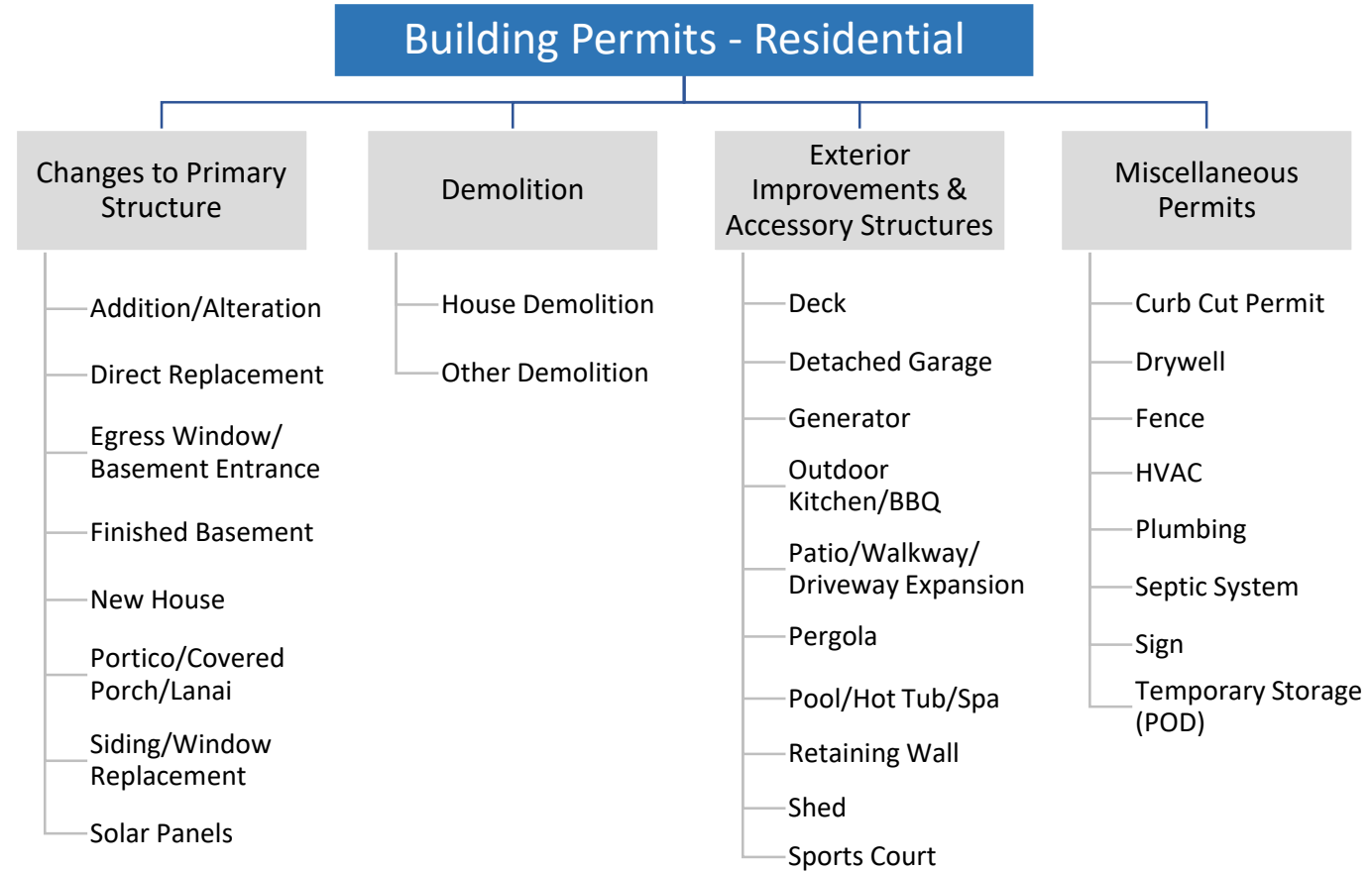

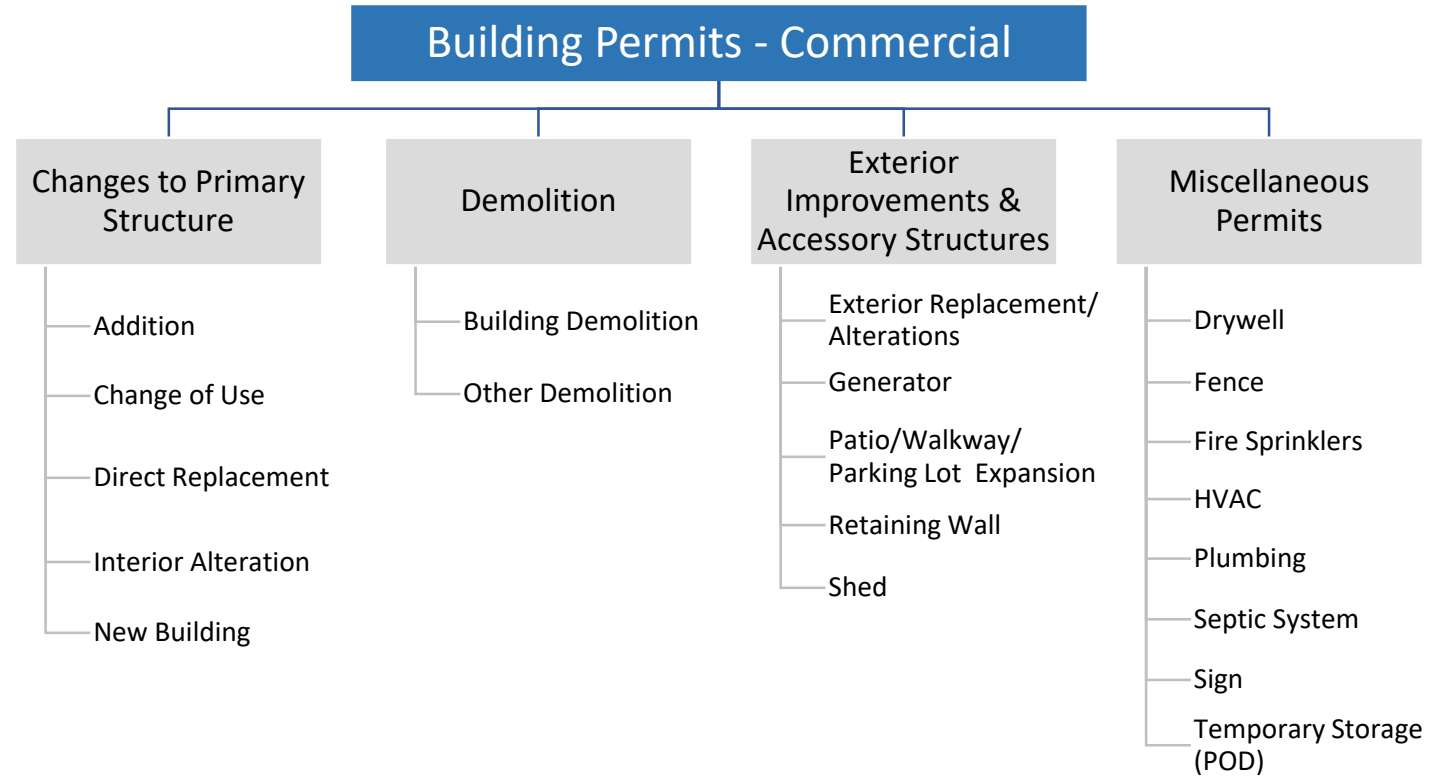

Permit reinstatement should only be used for permits that have been suspended.

Permits that have not had a Certificate of Occupancy or Certificate of Compliance issued **within 4 Years** of the permit issuance date will be considered suspended, and will need to be reinstated.

Simply fill out this application and provide all necessary information, and your permit will be reinstated for a period of 1 Year only.

If your permit is still not closed out by the end of that period, it will be suspended again, and a new permit reinstatement application will be required.

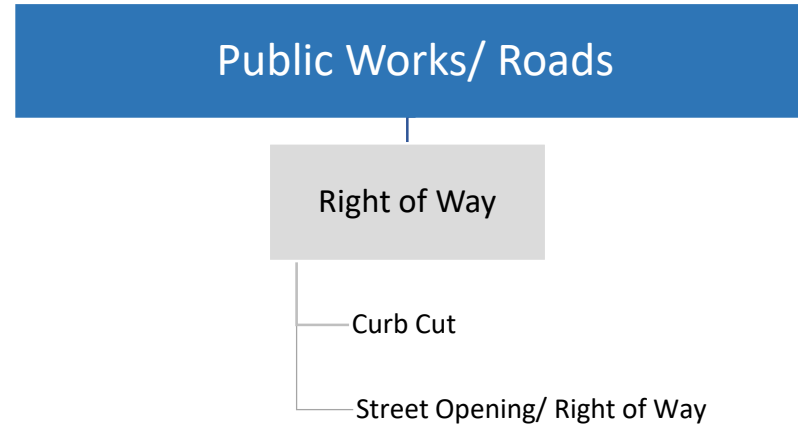

Public works/ road applications cover any road openings, grass openings, curb cuts, utility connects or disconnects.

Any work proposed in the Village Right-of-Way, which can include the street and 8-10 feet on each side of a street, must receive a permit from the Department of Public Works

Any tree removal 5" or greater DBH (Diameter at Breast Height) requires a permit.
